Typical ages for preschool classes are as follows:

TODDLER : 13 months to 27 months; TRANSITIONAL: 27 months to 3 years; PRIMARY: 3 years to 5 years

All tuition payment calculations are subsequent to the \$500 Non-Refundable Tuition Deposit, required at the time of enrollment.

* Families choosing to pay tuition in one payment will make the payment prior to May 1, 2013.

** Families choosing the two payment option will make the installment payment by May 1, 2013 and October 1, 2013.

This option includes a finance charge of 5% on tuition balance remaining after May 1st.

*** Families choosing the monthly payment option will make the first installment payment on either the 5th or 20th of May 2013. The remaining installment payments will be made every month thereafter. Monthly payment plans include a finance charge of 6% and require Tuition Refund Insurance.

**** Option to wrap 2013 Summer Program tuition into the 2013-2014 academic year 12 month payment plan.
